Dear First Minister and colleagues,

We expect you are already aware of the recent criminal and civil actions taken in England and the Netherlands regarding the deaths and injuries which have resulted from the global Covid 19 vaccine clinical trials (AKA 'roll outs') and the threat the vaccines continue to pose to public health.

If you are not already aware then we would like to take this opportunity to inform you of the following:

There is also an audio recording circulating on social media (attached file video\_2022-01-17\_19-48-56) in which a doctor, responding to a NHS 111 call, states, “*There’s a lot of information coming up now which was not available earlier and very soon all of the vaccines will be completely stopped.*” “*This is information that has just really come up. You won’t hear it on TV for a while probably.*”

When the guilty are brought to justice around the world (AKA ‘Nuremberg 2.0’) we suspect most judges, juries and prosecutors will take a dim view of those world leaders who continued to try to coerce the citizens of their countries into taking Covid 19 vaccines *after* they had been made aware of the true extent of the safety issues surrounding them.

We urge that you consider these matters seriously before you make your decision on whether or not to extend your Covid certification scheme to theatres, cinemas, hospitality etc. tomorrow.

In fact, we would advise that you immediately terminate the roll out of the Covid 19 vaccinations before anyone else is maimed or murdered.
